For WPX formal entries cleared by DHL broker, consignee must pay duties/VAT, other customs expenses and brokerage fees against delivery. All shipments must be accompanied by Certificate of Origin. Note following WPX restrictions:

- 1. Ministry of Communication approval required by consignee.

- 4. Multilated samples only, must be cut or stamped in a prominent place outside the garment. Maximum value: USD100.00.
- 5. Sample only. Tinned/Vacuum packed. Maximum weight: 1kg (2lbs).
- 6. Subject to screening by customs. Delay: 2-4 days.

### **Service Impact Notes**

Always ask the shipper if they have determined if their shipments required an export license to Azerbaijan.

### **Operation Notes**

All shipments for Ministries/Universities MUST have a contact person and phone/extension number. All WPX shpts must have phone/fax/telex numbers and contact names to avoid delays.
