### Worldwide Package Express

To reduce destination duties/taxes on WPX shipments to Israel: 1) Diskette shipments (duty is charged at USD 25 per diskette without the Certificate of origin); 2) Commercial shipments over USD50 Standard accessorial fee for Certificate of origin should be charged. WPX consigned to individuals will need copy passport for clearance. The following are the WPX restrictions:

- 1. Requires permit from Ministry of Health, import license for commercial quantity.
- 2. Harmless only, invoice must clearly state full description of contents and intended use.
- 3. Requires permit from Ministry of Health and prescription from doctor/hospital.
- 4. Import license class "A"
- **5.** Authorization from Ministry of Health and Israel standard institute.
- **6.** Authorization from Ministry of Communication
- 7. Authorization from Ministry of Agriculture. Import license. Phytosanitary Certificate in paperwork.

- 8. Authorization from Ministry of Communication. Import license.
- 9. If destined to ships in transit, clearance must be made by consignee or his broker.
- 10. Import license label in Hebrew, class "A" must be on invoice for commercial quantity.

## **Service Impact Notes**

All shpts destined to Gaza & west bank (GZA & ZDM) are subject to security checks by Israeli security authorities, these shipments will suffer an additional delay of 24-48 hrs. Clearance period for shpts limited to 45 days from arrival day. After 45 days, Israeli customs will confiscate shipments by destroying or auctioning. Shipments addressed to PO Boxes without a telephone number should not be accepted. Shipments to PO Boxes with telephone numbers will incur delays.

## **Operation Notes**

P. O. Box shipments must be with telephone numbers. Phone/fax # is required on all Israeli shipments. Return charges apply on all return to Origin shipments.
