- **1.** Shipment requires Health Ministry Certificate and Sanitary Registry number upon arrival. Expect 3-4 days delay for clearance. USD 35.00 minimum broker charge for processing. Shipments from USD .01-5000.00 pay 35.00 . USD 5001-10000 pay 55.00. Over USD 10001 pay 55.00 plus 0.15 CIF Value.
- **2.** Shipment must travel with copy of Import Certificate from Ministry of Agriculture; otherwise shipment will be seized on arrival and fines will be charged back to origin. Re-evaluation required regardless of value. Expect 3-4 days for clearance.
- 3. Permit issued by Ministry of Government and Justice.
- 4. Commercial Invoice must be itemized.
- 5. Commercial Invoice and AWB must read "not for sale/resale".
- **6.** Re-evaluation required regardless of declared value. Expect 3-4 days for clearance.
- **7.** *Unprocessed: Prohibited.*

Service Impact Notes

All commercial invoices must state "I declare under oath that the information described above is truthful. This invoice is endorsed to DHL Panama S.A for importation processing.

Operation Notes

All WPX shipments consigned to steamship must state "In Transit" and the vessel's name. AWB and commerical invoice must not have corrections or typos. Not adhering to these regulations will result in fines ranging from USD 250.00 to USD 500.00.
